## REQUIREMENTS

1. Certificate of Comprehensive General Liability that covers this type of activity and an **additional insured endorsement** with a limit of general liability of a minimum of \$1,000,000 per occurrence. There are several on-line companies that offer one-time event insurance. **Your party will be cancelled if there is no insurance information received by the district at least one week in advance of party.**
2. APRD Lifeguards are required for all parties. Two lifeguards are included with your reservation. You will need to provide information on how many people will be attending the event so that the appropriate number of lifeguards can be scheduled. If attendance of the event exceeds the projected attendance, additional lifeguards may be required at an additional cost of \$30/lifeguard per hour.
3. **All participants and invited guests must have a APRD Health Declaration form on file with the Arbuckle Parks and Recreation District until further notice.**

## POOL RULES

1. Pool patrons must wear proper swim wear. Patrons may enter the facility in street clothes but cannot enter the water without proper swim attire.
  - Children in diapers are not allowed in the pool unless they are wearing swim diapers.
  - Appropriateness of clothing, coverage or swimwear is up to the discretion of the staff.
2. Patrons with open sores, diarrhea, any infectious diseases, or who are openly bleeding are not permitted in the pool.
3. Children 10 and under must have a guardian with them who is 18 years of age or older. No child 10 and under may be left unattended.
4. Children 6 and under must be supervised by an adult in the water within arm's length reach.
5. Abusive, offensive or profane language will not be tolerated.
6. Running, pushing, wrestling or causing undo disturbance is not allowed. Misconduct is grounds for expulsion from the pool.
7. Lifeguards may exclude anyone from the deep water who has not demonstrated sufficient ability to swim.
8. Only toys made for use in the water are allowed in the pool. Staff can deny use of any items if they are misused or if they cause a disturbance.
9. Food is allowed in designated picnic areas only. No glass containers or alcohol of any kind are allowed inside the facility. It is the responsibility of the undersigned to make sure all garbage and food have been cleaned up and disposed of properly.
10. All personal items must be removed from the facility before the allotted time is up. APRD & PJUSD are not responsible for lost items.
11. Do not lounge or loiter near the lifeguard stands or talk with lifeguards while they are on-duty.
12. Drugs, alcohol, tobacco products and weapons are strictly prohibited. Possession will result in expulsion.
13. Non-service animals are prohibited.

**STATEMENT OF APPLICANT:** The undersigned applicant has read the rules and regulations. It shall be distinctly understood, and agreed, that subject applicant and related organization making this application assume *ALL RISK FOR LOSS, DAMAGE, LIABILITY, INJURY, COST OR EXPENSE* that may arise during or be caused in any way by such use or occupancy of the facility.
